SUBJECT: Main Street No Parking Zone & Permits

DATE: OCTOBER 19, 2023

SUMMARY

The city is looking at Parking Permits on Main Street to deter illegal parking on Main Street.

BACKGROUND

After several meetings between staff and the Public Works Committee, the City Council has instructed the City Manager to collaborate with the Public Works Committee for a No Parking Zone (permit). At council, there were several comments in favor and against. The main testimony against came from Micah Fornier, current renter of 79 N. Main Street. Mr. Fornier, testified against the proposed No Parking Ordinance, saying there should be no No Parking Ordinance between Ellis St. and the city limits. He said that if the trucks in his possession are too tall and obstruct the view of the school zone signs, he would only park vehicles with a lower profile as to not impede visibility of the signs. He further commented that there was water running over the street, from George Sperry's property (80 N. Main St.) and inundating his building and that of Sharon Houck (73 N. Main St.). His contention was that the poor state of the gravel on the north side of N. Main Street, was the leading cause of this water flow across the street. He also claimed that he previously complained to the city about this water issue. To remediate the problem, he also volunteered to put gravel down where the water was pooling.

Staff has looked at city records of all the properties in the immediate vicinity of the water pooling area and cannot find any record of complaints highlighting an issue.

FINANCIAL IMPLICATIONS

If enacted, parking permits to the city would generate some revenue, but likely only enough to cover administrative expenses.

ORS 811.550

Places where stopping, standing and parking prohibited

This section establishes places where stopping, standing and parking a vehicle are prohibited for purposes of the penalties under ORS 811.555 (Illegal stopping, standing or parking). Except as provided under an exemption in ORS 811.560 (Exemptions from prohibitions on stopping, standing or parking), a person is in violation of ORS 811.555 (Illegal stopping, standing or parking) if a person parks, stops or leaves standing a vehicle in any of the following places:

(18)

Within 50 feet upon the approach to an official flashing signal, stop sign, yield sign or **traffic control device** located at the side of the roadway if the standing or parking of a vehicle will obstruct the view of any traffic control device located at the side of the roadway. Exemptions under ORS 811.560 (Exemptions from prohibitions on stopping, standing or parking) (2), (4) to (7), (11) and (12) are applicable to this subsection.

Definition of Traffic control devices:

The Oregon Department of Transportation adopts uniform standards for traffic control devices, **including signs** and pavement markings for all streets open to the public in Oregon as required by statute (ORS 810.200). These standards must be largely in agreement with national standards. ODOT has adopted the federal Manual on Uniform Traffic Control Devices to meet this requirement. Part 7, Traffic Controls for School Areas, contains the standards for traffic control in school areas..
