

Rural Polk County 2025 Point in Time Count Data



The 2025 Point in Time (PIT) Count took place in late January across the United States. The PIT Count is a comprehensive count of the local population experiencing homelessness that measures the prevalence of homelessness in each community and collects information on individuals and families experiencing homelessness.

This year for our region, the Polk County Family & Community Outreach department partnered with over 15 local agencies and 30-plus community volunteers to ask people experiencing homelessness or at-risk of homelessness in rural Polk County where they slept on the night of January 22nd. Rural Polk County is defined as the areas West of Highway 51 including the cities of Monmouth, Independence, Dallas, Falls City, Willamina, Grand Ronde, and the unincorporated areas surrounding those cities.






UNSHELTERED HOMELESS

*At-risk of homelessness is defined as those who will lose primary residence within 14 days and have nowhere else to go.

























Homeless Prevention & Outreach Program

FALLS CITY CITY COUNCIL

MONDAY, AUGUST 4, 2025

Mayor Bailey called the Falls City City Council into regular session on Monday, August 4, 2025 at 6:03 p.m. in the Community Center located at 320 N. Main Street.

Council Members Present:

Council President Amy Houghtaling, Councilor Nick Backus, Councilor Tony Meier, Councilor Tia Scruton, Councilor Dennis Sickles, and Councilor Lori Jean Sickles.

Staff Present:

City Manager AJ Foscoli and City Recorder Jeremy Teal

Announcements, Appointments, Appreciations & Proclamations	There were no comments.				
Public Comment	Mayor Bailey noted he had seen the best and the worst of Falls City in the last few weeks. He mentioned each person had their own belief systems and he honored that, but communicating face to face would be the only way to resolve issues. He stated regardless of the activity in town, we may not agree but we should respect it. He advised that 2 Pride flags were vandalized in the 3 days they were up. He noted the poles were used for every event and when someone vandalized them it takes money from other budgets to replace them.				
	He advised that it was awesome all the projects around town and he understood the concerns about projects, but they don't happen overnight. He reported the original design for Safe Routes to School was from 2013 and the pedestrian island was exactly the same and in 2019 the school, the council, the committee were gung ho to create the safest route for kids to get to school. He advised that topography, the weather and unstable ground were all factors in moving the project to 5 th and Prospect in 2023. He noted the 2 things that remain are the pedestrian island and adding 5 ft of pavement to 5 th and Prospect after the open house in 2023 with the community feedback. He mentioned that there was thought and effort in everything the City and Council do for the community.				
	He noted there was concern about the power of the City Manager, but the Council was the ultimate authority. He mentioned the upper park bathrooms were completed in the winter of 2024				

with new floors, new stalls, new doors, new toilet paper holders, new hand air dryers that had to be wired in, new water heater which also had to be wired in, hot water pipes ran to each bathroom for the sinks, and recently painted. He encouraged everyone to go up and take a look as they look great. He noted the Valsetz picnic group praised them.

He reported the Skate Park was a huge undertaking, but the design was all paid for through donations from local residents. He noted moving forward all aspects of the project would be done in phases to allow for some work to happen and show progress. He noted he would apply for every grant he could to help with the costs.

He noted for anyone who doesn't understand grants, the City has to use every cent for those grants or they get penalized and have to return the money. There are no administrative costs allowed in any grants, so no kickbacks for staff. He noted all the records were at City Hall.

He asked everyone to remember that we were all here for the exact same thing, to make our town the best it can be. He noted everyone has different ideas, but coming together for a common goal was what made Falls City great. He advised the Council was chosen by you and represented you and if you didn't like it come to Council and let us know. He stated we were all in it together for the right stuff.

He thanked every person that helped and attended the event over the weekend. He noted the out of towners felt safe and happy to be here.

Mayor Bailey opened the public comments at 6:21 p.m.

Laura Britton apologized about her Facebook post and wanted to publicly apologize to the community, the Council and Mr. Foscoli. She noted the project had changed and it was all for the safety of the kids. She advised the project

was not removing anything but adding 5 ft of pavement to the edge of the street. She apologized for stirring up a ruckus and riling up the community on Facebook. She mentioned that she loved Mr. Lauder's tree, but it needed to come down for the project. She stated she loved the community and should have thought through it and gone to City Hall before posting.

Tracy Young reported there was a level 3 sex offender around town. She noted pictures were up at the school.

Jim Miner asked if the sewer was on schedule or behind. Mr. Foscoli noted they were behind schedule.

Mr. Miner asked about the drainage on Prospect Street. Mayor Bailey stated the plan was to hopefully create a bevel to help with drainage.

David Drake stated he was concerned there were no flaggers on Mitchell and 5th off of Pine and people could swing down there.

Mr. Foscoli noted that North Santiam Paving did that work and probably thought they needed minimal amount of flaggers. He stated he would make sure there were more flaggers next time.

Mr. Drake asked about the lack of law enforcement and asked if Deputy Silverman was gone. Mr. Foscoli Deputy Silverman had training, but other deputies should cover. He reiterated Deputy Silverman was only 10 hours a week.

Mr. Drake stated there was a kid riding on a mini bike downtown during Pride and he was not old enough and the bike was not street legal.

Council President Houghtaling noted she had addressed the kid, but Deputy Silverman beat her to it and he addressed the kid and he left.

Mayor Bailey stated he had a root beer together and discussed hitting people was not good.

Mr. Drake stated that Mr. Foscoli can't turn commenting off on Facebook. Mayor Bailey stated that if the post was informational, he could turn off comments.

	Mr. Foscoli stated he sends messages directly to people that do comment. He noted it was not a requirement to keep comments on. He told everyone to email him.
	Niki McKee gathered questions from the Facebook post that the community was asking regarding the Safe Routes to School project. Mayor Bailey asked for the list of questions so he could research them and get her all the answers.
	Tina Thompson asked if 5 ft was added for the project then where would cars park. Mayor Bailey stated the 5 ft was connected to the street and would give more room for people to park.
	Ms. Thompson stated that if the project was saving \$100,000 could the City clean up Ellis Street. Mayor Bailey noted that if the City could use that money for that we will do it.
	Mayor Bailey closed the public comments at 6:58 p.m.
Consent Agenda a) July 7, 2025 Minutes	It was moved by Councilor Meier to approve the Consent Agenda as presented. The motion was duly seconded by Councilor D Sickles and CARRIED with a vote of 5-0 with Councilors Meier, Scruton, D Sickles, LJ Sickles and Council President Houghtaling voting YES with Councilor with Councilor Backus abstaining as he was absent.
Reports or Comments from Mayor and Council	
Members a) Mayor's Report	Mayor Bailey reported that line paint had come in and he would be painting the crosswalks before school started. He asked for volunteers to help clean up stairs before school started as well. Mr. Drake noted he had an effective spray for blackberries if that was allowed.
b) Councilor Comments	Councilor LJ Sickles thanked everyone for their hard work making Pride successful.
	Council President Houghtaling assured the residents that the City was not hiring relatives or unqualified people. She noted the bid process was done publicly with 6 bids and North Santiam

Paving being the lowest bid. She mentioned North Santiam Paving was out of Stayton and had 50 years in the field and were licensed and bonded with no affiliation with the City or Westech. She announced that the Back-to-School bash would be Sunday, August 24.

Councilor D Sickles noted that projects the City does were vetted thoroughly before ground was ever broken. He stated that surveys, studies, public comments, public hearings, and positive input from open house were completed before any bid went out. He noted it was important to come to meetings and voice your opinion especially regarding projects that effect our City. The Council does listen to the residents and did scale back the safe routes project to accommodate someone's property. He noted our community was stronger when we worked together. He mentioned that posting stuff on Facebook would never work and it just fires up people that don't have all the full information and it pulls the community apart.

Councilor Scruton mentioned the last outdoor movie night was on August 15th, and bingo was on August 23.

Jeremy Gordon stated he moved here 10 years ago and was excited to see the City focusing on infrastructure with a road project, sewer project and a water project. He noted Falls City had the trust of the funding agencies and the community was engaged and looking for the future.

Councilor LJ Sickles stated the committee recapped the summer celebration and upcoming Pride. Mayor Bailey thanked everyone for the summer celebration.

Councilor Meier stated the committee thought 25 mph was good for whole city except for the school zone set at 20 mph.

Mayor Bailey stated South Main would like it to be 20 mph. He noted that adults and kids need to take responsibility when driving in town. He

	Mr. Foscoli thanked Ms. Britton for apologizing. He noted we all make mistakes and need to own up to them. He stated the public apology was greatly appreciated.

City Manager's Report Sept. 8, 2025

Introduction

August was a very busy month in Falls City with a great deal of mobilization from the three major contractors and several subcontractors trying to bring their projects to a close or beginning new ones. The near-completion of the Lagoon project will have start-up and switch over delayed by a month due to a computer module reprogramming, the water mainline as well as Safe Routes to School project projects are progressing steadily. These projects, once completed, will improve the quality of life in Falls City through better service delivery of water, wastewater and transportation.

<u>Wastewater Project</u> – The regular meetings with Strider Construction and our contract engineers are still on a tri-weekly schedule as work is progressing steadily at the lagoon site, and within city limits. As PacifiCorp powered up the school campus' new pump station's electrical conduit, and the power connection at the lagoon site, testing of the computer controlling modules has identified a hardware issue that the contractor is working to resolve. Once the new modules are in place, both facilities will be ready for continuity testing the sometime in September. Once the testing is complete, Strider will begin the switch-over and begin the demolition of the decommissioned facilities (old treatment equipment, the gravel filter and recirculating tank).

Code Enforcement — Our Code Enforcement Officer has been coordinating with the Polk County Sheriff's Office Deputy to address several code compliance instances. In particular, a new RV has been parked illegally on the city's right of way and both officers have worked on its removal that was supposed to happen by the end of last month. As mentioned before, the city has no budget to dispose of RV's (ranging from \$3,000~5,000/RV), therefore it explores all avenues to get to voluntary removal from RV owners. The owner of the RV has stated multiple times that they are more than willing to leave the city, if the RV could be functional, so the city is exploring avenues to make this happen. Work is also continuing on getting the Ellis Street noncompliance issue of accumulating garbage under control and is working directly with property owners on mitigation. The latest estimate for the clean-up is \$3,500 and we are working on a timeline to expedite that before the fall's rains. The city is continuing to pursue an Intergovernmental Agreement to contract with one of the Polk County neighboring cities for municipal court services, to handle non-compliant cases.

<u>Community Resource Center Project –</u> The Falls City Resource Center's operation is busy as with several service providers assisting clients at the building. The Federal reduction in assistance for rural healthcare has impacted many jurisdictions and organizations, and the Resource Center is no different. They are currently slated to lose their kid snack handout ability,

unless a funder can be found to provide roughly \$200/month. Though not a lot in the grand scheme of things, it does make a difference to youth who face food insecurity. In August, there were 543 total interactions (down 35 from July): 73 set appointments, 269 Youth coming for snacks & activities, 48 adults getting snacks, food/MREs. Only 69 were non-Falls City residents.

<u>Household Burning Ban</u> – As the community has seen an increase in properties burning household garbage within city limits, which negatively impacting air quality, the city enacted a new ordinance to curb such behavior. City staff, in collaboration with the Fire Department will bring a Household Burning Ban Resolution Fee schedule for council deliberation at the September meeting, due to Chief Gilbert having been deployed on two conflagrations during the month of July.

Water Conservation -

The lack of rainfall these past couple of very hot months is leading us to conserve water. Residents have been using over 450,000 gallons a day these past few months (normal average in summer is 300,000 gallons). If usage continues at this pace, the city will have to start dialing back the amount of water it can distribute to residents. Please consider these water saving tips:

- Water lawns & gardens during the cooler early morning or evening to minimize evaporation.
- Refrain from washing cars or pressure washing sidewalks and driveways

<u>Upper Park Trees</u> – The city is still working with the Department of Forestry to decide on a schedule for the 5 trees that will need to be brought down. When the schedule is decided, Public Works staff will coordinate with the community to ensure everyone's safety.

<u>Town Hall Meeting</u> – Next Town Hall Meeting is planned for Monday, October 20 at 6:00pm.

<u>Summer 2025 Infrastructure Construction Projects</u> –

Safe Routes to School Pedestrian Island and Path Project:

- North Santiam Paving is continuing road work on the 3-way intersection at Bridge/N.
 Main/Mitchell intersection
- Paving up 5th and Prospect has been completed
- Construction is slated to continue for a period of 120 days (from the start time)

Water Mainline Replacement Project:

- Trench Line Excavation Inc. has been replacing several failing water lines at:
- Hopkins Avenue, portions of 2nd, 3rd, 4th Streets, Pine Street, alley between Pine Street
 N. Main Street, and Estelle, Clark, East Clark, and Forest View Lane.
- Trench Line Excavation, assured the City that none of the roads will be fully closed, and residential access will be maintained throughout the construction.
- Project start date is scheduled for mid-August, for a period of 120 days
