# Goal 1 Upgrade Sewer Infrastructure

Milestone	Status	Notes
Environmental & Engineering Design Complete	Complete	Westech Engineering finished the design for the Wastewater Treatment plant and sent it out to bid according the CDBG funding program. All Federal & State organizations that have jurisdiction over environmental impacts, such as NMFS, NOAA, ACOE, DEQ, USDA gave their approvals to move on to the funding phase for the construction.
Construction Financing Options Known	Complete	DEQ permanent funding for construction was deemed the most financially beneficial based on interest rates and term of loan, CDBG and ARPA funding rounded out the project package of \$5.25 million
Community Information & Outreach Conducted	On Target	Monthly updates from City Manager on the project have been ongoing. Rate analysis (Summer 2020), presented to Council by project engineer and project manager.
Construction Grants Applied For	Complete	FC staff, after coordinating with NMFS, NOAA, ACOE, DEQ to identify funding options for the required environmental assessments identified DEQ permanent funding as final option
Land Fully Acquired	Complete	All Easements finalized, purchase of lagoon site finalized, IGA with School District as condition for easement finalized, property line adjustments through Polk County, with the help of MWVCOG all processed
Construction Begun	On Target	Based on current timeline for construction funding package, construction will end by Q4 of 2024
Facilities Plan Amendment Done & Adopted	On Target	Once the project construction is complete, a facilities plan will be amended with Westech Engineering
